- We undertake to accept and abide by the Admission Policy and Code of Conduct of the School, and all other policies, rules and regulations of the School's Governing Body.
- I declare that I/We are in a financial position to pay the school fees as adopted.
- **I undertake to pay a non-refundable deposit amount of R6000.00 by no later than 14 working days after my daughter has been accepted by the school, the amount of which will become deductible from the fees due during the first term. - I undertake to pay all fees due in advance at the beginning of each term. I understand that the payments received will firstly be credited to the school account and then boarding fees. Failure to settle boarding fees in advance will result in the learner being requested to vacate the hostel with immediate effect.
